After a question about what exactly the law entails, there were no further comments. The public hearing was closed at 7:05PM.

The regular meeting was called to order by Supervisor Donnie Smith.

Present were Donnie Smith, Garret Sitts, Heather Ross, Teddie Storey, Dwight Bruno, Jamie Archibald, Paul Warner and Gregg Pitula. Also present was Amber Gray.

The minutes were read from March 3, 2026. Dwight Bruno made the motion to approve minutes as read. Heather Ross seconded the motion. All present agreed.

Garret made the motion to accept Gerster's out of Cobleskill Stone bid of \$11.00 for all size stone with Cobleskill Stone at \$12.85 as a backup. Teddie seconded the motion. All present agreed.

Garret reported for KECC. They will be doing community garden again. They are getting the sports fields ready and are speaking with Jonah Shaw about being able to use the gym for basketball. Their financials are solid.

Heather said the rec commission was scheduling their first meeting but has heard nothing further.

Gregg has started getting requests for permits. Not as many municipal searches as there has been, which means not much being sold as fast as it was. Had a few complaints, nothing major.

We're looking for a new dog control officer.

Teddie said the planning board had 2 BLA and a simple subdivision. Also classified one bookshop as home occupied business.

Jamie said they picked up their widener. Only nine days of plowing this month. They have all the sand in for next year. Have been working on the roads but they are still pretty wet.

He said he would like to rent the grader for May and June. Garret made the motion to rent grader for \$4500.00 per month plus trucking. Heather seconded the motion. All present agreed.

Luke Potrzeba spoke about the Treadwell Water District. There is a group that is working on the next grant application as there have been some issues with the past applications. They will make sure that it is complete.

Resolution 6 – 2026 approving Local Law -1- for Prior Written Notice was read. Heather made the motion to approve Resolution. Teddie seconded the motion. All present agreed.

The SEQR was read and Teddie made the motion for Negative Declaration.

Dwight seconded the motion. All present agreed.

Vouchers 2026-124 - 2026-168 were presented for payment.

Heather made the motion to go into executive session for contractual issues at 8:30 PM. Dwight seconded the motion. All present agreed.

The board returned from executive session at 9:00.

Garret made the motion to purchase a stainless steel box for one of the trucks for \$48,623.00. Teddie seconded the motion. All present agreed.

Garret made the motion to purchase a 2005 Western Star truck for a parts truck, as we can use many of the parts, for \$8000.00 including delivery. Teddie seconded the motion. All present agreed.

With nothing further to come before the board, the meeting was adjourned at 9:10 PM.
