| Major Subdivision   | \$1,000 for first lot and \$100 for each additional lot.   |
| Payment in Lieu of Parkland   | Parkland fees are required to be paid for any major residential subdivision. At the time of the submission of the Subdivision Application, a fee of One Thousand Dollars \$1,000 per lot must be submitted with the application (this includes the parent parcel). In the event the application is ultimately denied, the Parkland Fees will be returned. If the approved numbers of the lots is increased or decreased by the Planning Board, the Parkland Fees will be adjusted accordingly. If additional fees are required to be paid due to an increase in the number of approved lots, such payments shall be made prior to Final Planning Board approval. Reimbursement of any overpayment of Parkland Fees shall be paid following Final Subdivision Approval.   |

| General Professional Fees   | The Applicant is responsible for the expenses for professional fees incurred by the Planning Board and Zoning Board of Appeals or the Code Enforcement Officer for professional fees which are incurred as a result of professional work required to be done on behalf of either of the Boards as a result of the filing of an Application seeking approval by such Applicant. Professional fees include the fees of architects, engineers, planning consultants and traffic consultants, together with certain fees of the Town Attorney rendered in connection with the Application. Upon the Boards receiving a statement from the professional setting forth the nature of the services performed, the dates such services were rendered, the times spent thereon (if such services are rendered on a timed basis) and the name of the party rendering such services, together with a voucher or other bill rendered to the Town, the applicant must pay the following fees upon the earlier happening of the following events (i) the next meeting which the Applicant wishes to attend; (ii) prior to and as a pre-requisite for final approval. |
| <p>All fees payable at the time of application</p> <p>Note: If the Application is granted but the fee is not paid, the Board or Code Enforcement Officer can revoke its action ex parte and then notify the Applicant of the revocation; thereafter the Application sought will not be granted until the fees are paid in full.</p> <p>* There shall be no fee for an initial consultation with the Planning Board prior to submitting an application. There shall also be no charge for the first meeting with the Planning Board after the full application is submitted. However, when the applicant fails to provide the required information to subsequent Planning Board meetings, the Chairman shall impose an appearance fee of \$100.00 after the third meeting.</p> |  |
